To announce the 2016-2017 District Senior High School Mock Trial Competition. Students prepare and argue a civil or criminal court case during the District competition being held on February 23 and 24, 2017.

- The District's Senior High School Mock Trial Competition will take place on February 23 and 24, 2017. The location is: James L. Knight Center, 400 SE Second Avenue, Miami, Florida 33131. Please note the following important competition and registration information:
 - Schools may only register one team for the competition.
 - The Senior High School Mock Trial case can be downloaded by clicking on the provided link: [2017 Senior High School Mock Trial Case Packet](#), or it can be downloaded from the Florida Law Related Education Association's (FLREA) website, www.flrea.org, click on Programs, Mock Trial, and see the "2017 Mock Trial Case Packet" link.
 - The District competition is completely governed by the state rules, which are attached to this briefing, in order to avoid confusion to the team that advances to the state competition and so that students only have to learn one set of rules.
 - The District competition will NOT use power matching to conduct rounds as described in the state rules.
 - The District competition will still use a student bailiff/time keeper from each school to assist with the logistics of running the competition. Failure to bring a bailiff/time keeper will result in not being able to participate.
 - To assist in covering the costs associated with holding the District Competition, registration fees are as follows:
 - Public and Charter schools - \$75.00 registration fee; and
 - Private schools - \$250.00 registration fee.
 - Details of how to submit payment will be sent directly to team sponsors once the registration process has been completed.
 - Substitute coverage will be provided to all non-charter public schools for one teacher/sponsor from each participating school for both days of the competition. Transportation will not be provided.
