The Department of Social Sciences is sponsoring the 27th annual "We the People... The Citizen and the Constitution" district competition on Friday, December 12, 2014.

- "We the People...The Citizen and the Constitution" competition provides Senior High and Middle School students with the opportunity to demonstrate their knowledge of the U.S. Constitution and Bill of Rights by taking part in a simulated congressional hearing.
- This year's competition is scheduled for Friday, December 12, 2014, at the James L. Knight Center 400 S.E. second Ave., Miami, FL 33131.
- To assist in covering costs associated with the District competition, each public and charter school participating must pay a \$50.00 registration fee and each private school must pay a \$100.00 registration fee. Details of how to submit payment will be sent directly to the team sponsors once registration forms are received.
- The winning senior high school team from each Congressional District, as well as, the winning middle school team will travel to Orlando in January, 2015, to compete in the state competition.
- The Department of Social Sciences will assist schools in covering costs incurred in advancing to the state level competition.
- Teachers must have implemented all six units of the "We the People...The Citizen and the Constitution" workbooks in order to participate in the competition.
